**The purpose for and grounds on which we process personal data**

**Automated decision-making**

Geurts Champignons Milheeze does not make decisions on the basis of automated processing in relation to matters that could have consequences, considerable or otherwise, for individuals. These are decisions made by computer programs or systems, without the involvement of a person (e.g., a Geurts Champignons Milheeze employee).

**How long we store personal data**

Geurts Champignons Milheeze does not store your personal data any longer than strictly necessary to achieve the purposes for which your data is collected.

**Sharing personal data with third parties**

Geurts Champignons Milheeze only provides data to third parties if this is necessary for the execution of our agreement with you or to comply with a legal obligation.

### **Cookies or comparable technologies we use**

Geurts Champignons Milheeze only uses technical and functional cookies. As well as analytical cookies that do not infringe upon your privacy. A cookie is a small text file that is stored on your computer, tablet or smartphone when you first visit this website.

The cookies we use are necessary for technical operation of the website and your ease of use. They ensure that the website works properly, and, for example, they remember your preferences. This allows us to optimise our website. You can opt out of cookies by changing the settings in your internet browser, so it no longer stores cookies. Furthermore, you can also delete any information previously saved via your browser settings.

### **Inspecting, modifying or deleting data**

You have the right to view, edit and delete your personal data. You also have the right to withdraw your consent to data processing or to object to the processing of your personal data by Geurts Champignons Milheeze, and you have the right to data portability. Please attach a copy of your ID to any request for inspection so that we can be sure that the request has come from you. In this copy, black out your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Social Security Number ('Burgerservicenummer'; BSN). This is to protect your privacy. We shall respond to your request as quickly as possible, within four weeks at the most.
